Steps to apply to be a food vendor:

- 1. Carefully review the attached packet
- 2. Fill out the online form
- 3. The Rivergate Festival Committee will review applications and make their decisions by Wednesday March 6th at the latest. At this time you will be notified via email whether or not you have been approved to join the festival as a vendor.

By filling out an application, it does not automatically mean you are registered as a vendor at the festival. The Rivergate Committee carefully chooses who the food vendors are, as to create the best experience for our attendees.

Please read and accept Terms and Conditions.

Terms and Conditions:

- 1. Setup is only permitted during the following times: Friday April 19th from 12pm until 3:00pm. Unfortunately this year we cannot allow set up after 3:00pm on Friday. You may park and walk your items to your booth after this time, but no car or truck traffic is allowed in the Food Truck area after 3:00pm on Friday. No food vendors are allowed to set up before Friday at noon. That means do not come here and park your trailer on Thursday. Friday at noon is the absolute earliest.
- 2. Vendor spots will be assigned upon arrival.
- 3. Please call Laura at 662-357-8010 when you arrive and a festival volunteer will direct you where to go.
- 4. Products sold must be listed and approved by Tunica Rivergate Committee.
- 5. The committee reserves the right to refuse a vendor to the festival. We are a small festival and we pick and choose our vendors as we see fit, according to what will appeal to our attendees the best. This is not personal, we just want to offer a wide variety of foods to our visitors and residents during the festival.
- 6. Absolutely no crawfish is allowed to be sold by festival food vendors.
- 7. Some 110 Electricity is available and there is limited water supply
- 8. The vendor will be responsible for reporting their own taxes.
- 9. Tunica Rivergate festival is a rain or shine event. Unless there is a weather emergency, the festival will go on. Booth rates are not refunded due to weather.
